On August 2, 2019, the Legal Services Corporation (LSC) released its Annual Report with its statistics and goals accomplished during 2018. In 2018 the LSC provided grants to 132 independent, nonprofit organizations that provide free civil legal services to low-income Americans from 852 offices located across the United States and its territories.

LSC is the single largest funder of civil legal aid for low-income residents in the U.S. and U.S. territories. The organizations that we fund help people who live in households with annual incomes at or below 125 percent of the Federal Poverty Guidelines.
