NORTH DAKOTA CONCEALED WEAPON LICENSE

An individual who is not a resident of North Dakota may apply for a North Dakota concealed weapon license but cannot use the license as an alternate to a NICS check when purchasing firearms. LICENSE PERIOD . Licenses issued prior to July 1, 2011, are valid for three years. Licenses issued on or after July 1, 2011, are valid for five years.

10. "Plain view" means the handgun is placed in such a location or carried in such a position as to be easily discernible by the ordinary observation of a passerby. In a motor vehicle, this includes being placed on the seat, dashboard, or in a gunrack as long as the handgun is not covered or is in any other way concealed from view. 11.

CONCEALED WEAPONS 62.1-04-01. Definition of concealed. A firearm or dangerous weapon is concealed if it is carried in such a manner as to not be discernible by the ordinary observation of a passerby. There is no requirement that there be absolute invisibility of the firearm or dangerous weapon, merely that it not be ordinarily discernible.

Instructions are on the concealed weapon license page of the website, www.ag.nd.gov . RECIPROCITY North Dakota has "reciprocity" with many, but not all, other states. This means that a North Dakota concealed weapon license is valid while in those states, and licenses from those states are recognized as valid in North Dakota.

North Dakota Concealed Carry Permit and Laws. North Dakota is a "Shall Issue" state, and although they allow open carry, permits are required in some situations and for reciprocity. For example, you cannot have a gun in your vehicle unless you have a concealed carry permit. The attorney general's office issues concealed carry permits.
