The article 124 of the Constitution which regulates the Prosecution Ministry, in its second paragraph establish the main four principles that should govern the action of the Public Prosecution: The Prosecution Ministry shall discharge its duties through its own bodies in accordance with the principles of unity of operation and hierarchical subordination, subject in all cases to the principles of the rule of law and of impartiality.
